Program Guidelines

About Project Blue World Foundation: Project Blue World Foundation PBWF is a non-profit organization incorporated in 2019 for the purpose of providing professional management and administration services and resources for the benefit of the community.

Project Partnership Details:

Project Partnership provides professional services and other resources required to achieve the partners charitable goals. Timeline for full project development and management services is minimum one year, often multiyear, renewable at annual intervals. Project Managers and other professionals are assigned as required to develop the project from initiation and planning through execution of activities. Monitors and controls are put in place as project becomes self-sustaining, and / or project is completed.

Project Partnership program provides full management and coordination of projects. Projects with non-profit, non-registered charities are often organized using a capacity-building approach. PBWF establishes a long-term relationship with the project partner organization with the goal of the partner taking over the program, and PBWF withdraws its resources entirely to leave the project's successful operation in the hands of the former partner.

Selection Criteria:

- Projects and partners are selected by the project selection committee (members of PBWF volunteer board) based on fit of the project to the selection criteria and of PBWF ability to serve. PBWF must have the right expertise and resources to be able to provide support or may refer, decline or wait list your application.
- Project partners are 'Qualified Donees', Canada Revenue Agency CRA registered charities and 'Non-Qualified Donees', intermediaries that are non-profit and non-governmental organizations NGOs that are not registered charities with CRA.
- Applicants need a well-planned approach, goals and purposes and must be available to meet regularly and provide ongoing information, communications, approvals and work instructions as required.
- Projects must be charitable* in nature and have objectives to relieve poverty, develop education and other purposes beneficial to the community.

Note: Resources to provide support are developed every day, unfortunately we are not able to support every application.

*To be charitable a project must be designed and implemented for the welfare of society and focus on crucial elements of human life, like health, education, food, home, protection of the environment, and so on. Charitable projects benefit the needy in society.

Project Financing Details: Funding is provided by fundraising, donations and sponsorships, corporate social responsibility programs from individuals, small businesses, corporations, government and other granting organizations. These gifts are invested in development projects to further partners goals in installments over the life of the project based on satisfactory performance ('funding' includes the transfer of funds and all other resources). Funding may be withheld or withdrawn if required. 15% of funds raised go to administration costs of the foundation.

Using PBWF Project Management System, tools and techniques the partnership program includes receipt and disbursement, direction and control of funds and resources over the life of the project. Project receipts and expenditures are coordinated collaboratively between PBWF and Project Partners. Purchases of resources for distribution required for individual projects are done using cost elements based on the equipment breakdown structure provided by each project plan. Funds will be managed either through separate bank accounts or in books and records. Written financial and progress reports show receipt and disbursement of funds and the progress of activity.
